RE: Response to Questionnaire re Accountability for Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment Thematic Report of the Special Rapporteur on Torture to GA76

CitizensAHT is a non-profit organized to support individuals whose lives have been deconstructed, who are attacked with directed energy weapons and suffer organized stalking. We will answer these questions as they relate to the group of society we serve – Targeted Individuals. TI's are a small nation of dehumanized outcasts of society who suffer the same treatment separately across the globe.

- 1. Challenges to accountability: What are the most important legal, practical and other challenges that are conducive to the current worldwide accountability gap for torture and ill-treatment?
 - a. There is no gap. There is a wide-open non-accountable expanse. Consider everything that happens to a TI.¹ This program is a professional, perfectly planned buzzing cosmos of paid criminals who have been given the authority to act above the law, to secretly poison, torture, maim and kill without interference or remonstrance by the authority of world governments. In fact, the criminals are given Mason-like ceremonies where they are elevated and extolled for their good citizenship. They are given plaques for their walls certifying their distinguished membership. They receive parties, money and gifts. This is government at the city, county and state level. The authorities are the program. Police, firemen and medics operate directed energy weapons and stalk their TI victims, so how can a disenfranchised single tortured targeted individual hold all of that accountable? No contest.
 - b. Covertness. TI torture is such a sleek, covert, systematically designed program where individuals can be isolated and targeted without witnesses and the crime is covered up by the design of the system itself. Expert intrusion methods and superior technology assures no one is seen committing a crime. This requires multiple levels of secrecy among people who must maintain power (government) and money (bankers) by squashing anyone from the whistleblowers who won't cover up corruption to artistic oddballs, who are true to themselves and can't be molded into frightened obedient smart phone toting zombies.
 - c. The UN created Agenda 21² countries (178) have allowed the propagation of corruption of legal, medical, economic systems to treat TI's differently and keep them out of society and its services while keeping all their activities covert. No country wants to be left out so they all joined without full understanding of the covertly crafted cover-up of communism with

green this and that. Legislation reform helped create this systematic global program.³ Post 9-11 politics⁴ created the Patriot Act which expanded surveillance to the extent it can totally destroy a human being without even accusing them of anything or giving them a chance to defend themselves or even knowing they have been voted up for discussion at all.⁵ Post 9-11 created agencies and policies allow the categorization of innocent people as non-human so that they can be used for human and sex trafficking, and medical experimentation (reduced to animal status).⁶

- d. TI's cannot get away from electronic torture or stalking. Agenda 21 and its resulting alliances can perpetrate the exact same torture seamlessly from country to country. Agenda 21 is an overlay of lies beneath candied words about equity and justice, but not for TI's. The UN is very well aware that globalist pre-crime enforcement⁷ is ongoing, punishing people before they have committed a crime, and extending the torture to family members like street gangs. There are many agencies, government, military, scientific, manufacturing, educational and medical fields have contributed to the TI program which resembles the Zerzetzung,⁸ with the addition of directed energy, sonic and light weapons, drones, satellites and the WBAN.
- e. There are so many involved in operating the Targeted program, it would be a godlike task to hold every person accountable. The only way to hold all accountable and stop the targeting, would be to systematically dismantle the program, acquire all records for each TI, defund Fusion Centers, eliminate the FISA court and jail all of its judges. Eliminate all administrators and contractors controlling the operation of directed energy weapons, communications systems being used as weapons (cell phones and towers) and stalking programs such as COPS⁹. The state of Maine is taking on this task.¹⁰ Utility companies, cell phones companies, power companies all are complicit, as well as the restaurants who poison TI's, motels and hotels that torture TI's as they sleep and the monsters who operate the V2K system and remote neural monitoring systems.
- f. Double Jeopardy. Targeted Individuals are under another covert secret government with no scruples and no laws that govern the perpetrator. TI's are held accountable under regular laws and also subject to some unwritten code that punishes them for being alive. The TI program has no legal right to exist and is covertly administered, therefore, the TI has no one to point to, no one to hold accountable. They don't know who implanted them nor who is pointing the weapons at them. How do you hold someone accountable when you can't see them or the weapons being used. You can't see microwave and you can't see sound but your body is the instrument which tells you that you are being vibrated, burned and raped.

- g. TI's are separated from society and the law, they cannot get lawyers. There are punishments and death awaiting for any TI who uses the law to protect themselves. The program against them extends into the courts which dismiss their cases. They are denied medical treatment and tests which they need for support of their claims. TI's are tormented to the point physically that they cry out of help. They try to defend themselves and are put into psychiatric hospitals. This is a standard practice for TI's, so how does an individual who has been systematically labeled a psychiatric risk, delusional, alienated from family, job, property and resources fight the entire United States of America and hold it accountable? The word "gap" is not an appropriate word to define the enormity of disparity of justice and loss of rights and being made a non-human by being labeled a psychiatric patient when you are not. All the people and entities who take part in this fake mental illness campaign and terrorize with violent arrest, innocent people who cry out when they are burned, electronically raped and tortured with directed energy and stalking need to be accountable, even if they are just following orders or "doing their job".
- Functions, forms and levels of accountability: Please identify, explain, distinguish or compare the different functions (e.g. punitive/reparative, or proactive/preventative etc.), forms (e.g. legal, political, economic or social etc.) and levels (e.g. individual, collective, institutional, State etc.) of accountability for torture and ill-treatment.
 - a. Every nation that runs the TI program needs to make reparations for all the losses and pain each TI has suffered. There have been many TI's already "suicided" who need justice. They did not kill themselves. Susan Watkins did not hang herself in her closet.¹¹ Kim Straub did not shoot herself, she had a written non-suicide agreement with several organizations. The truth needs to be sought and their friends and families remunerated for their loss.
 - b. Huge lies have been told (9-11) but even with a preponderance of evidence, there is enough political and legal clout to keep the truth hidden. An entire overhaul of the constructions of post-9-11 politics, Agenda 21, the Patriot Act, and the illegal FISA court would be needed to account for all the corruption that allows overwhelming surveillance, loss of income and property, freedoms, privacy and indiscriminate killing of innocent people who have not committed or accused or any crimes.
 - c. The level of crimes committed by the TI program are global, Agenda 21 countries, states, counties, cities, 3-letter agencies, medical and scientific institutions, universities, so many.
- 3. Rights of victims: Who should be recognised as a victim of torture and ill treatment, and what are or ought to be victims' procedural and substantive rights within accountability processes? Who else, if anyone, should be entitled to have access to and/or participate in accountability processes and mechanisms?
 - a. TI's who have been transfected with Morgellons. Each victim is chosen and deliberately infected with very complex synthetic biological organic/inorganic materials, genetically engineered bacteria and animals including arthropods, spiders and worms. Agrobacterium¹² has been engineered to create a symbiotic relationship between animals and humans.

- b. TI's who have been implanted with any tracking devices, the Wireless Body Area Network,¹³ mind control devices, brain to brain connections,¹⁴ or brain to machine connections.¹⁵ They are being used for human medical clinical trials without their knowledge or consent. They should have free testing to prove implantation and have the implants removed, if possible.
- c. Tl's who are experiencing the vast array of mind control, V2K,¹⁶ electronic rape, body modification with microwave, connection to drones and satellites.¹⁷
- d. All TI's should have the right to face their torturers and see them pay for their crimes. Every right given to each person by the constitution has been taken away. The pursuit of happiness is not a possibility.
- e. The children of TI's have been tortured in their car seats with directed energy, vibrating and heating them and making them squirm and take off their clothes. Toddlers don't know what's going on. Children are being implanted in the head and ears, injected and used for medical experiments.¹⁸
- f. All the TI's who have been tortured to death. The TI program is for life. There is no way out. There is no relief from the directed energy, stalking and in your face surveillance until your eyes close in death. The perfect crime is where the killer gets away with it and they are. There is so much suffering because of this program, nothing could ever make up for it.
- 4. Recommendations: Based on your experience and/or analysis of accountability in (2) and (3) above, what are the most effective mechanisms / measures and/or good practices that can or should be taken to respond to the challenges you identified in (1) so as to ensure accountability for torture and ill-treatment worldwide?"
 - a. Organize protest against the TI program. Educate the public that it is real and is happening.
 - b. Re-educate the companies and organizations which cooperate with carrying out TI program.
 - c. Dismantle the program, FBI, FISA Court, Homeland Security, Law enforcement. Re-educate the emergency services, hospitals and doctors that TI's deserve just as good care as anyone.
 - d. Create laws against the use of directed energy weapons use on humans.
 - e. Stop illegal surveillance and make illegal all use of technology that allows it.
 - f. Hold the creators, organizers, implant manufacturers and weapons makers responsible.
 - g. Defund the TI program. Defund and Dismantle Agenda 21 and all post-9-11 legislation.
 - h. Defund the United Nations and all its globalist agendas and propaganda.
 - i. File class action suit to remove all perpetrators from society because they don't know how to be humans and bring justice to all TI's.
